

WORKSHOP "SMALL-SCALE FISHERIES in the SOUTH"

June 25th-26th, 2018 - Brest, France

CONTEXT

University of Brest (UBO) based Ocean University Initiative, French National Research Institute for Sustainable Development (IRD) and Too Big To Ignore (TBTI), Preface and AWA consortium have invited a workshop on Small Scale Fisheries in Brest, 25-26 June 2018.

OBJECTIVE

40 researchers, managers, funding agencies, training institutions and consultants are invited to discuss issues for a better integration of research in development programmes and development aid supporting sustainable small-scale fisheries.

FORMAT

The workshop is organized in 7 sessions. Participants other than speakers in thematic sessions are invited to present their domain of interest in relation to SSF during the introductory session, first morning, intended to facilitate networking. Six thematic sessions are introduced by 2 or 3 presentations followed by a discussion. The first three sessions present feedbacks from several international research programmes dedicated to SSF in the South. The two following sessions provide views by managers, funding agencies, educational agencies, and consultants engaged in SSF. The closing session will summarize key messages from all sessions for the purpose of producing a position paper that will be presented at 3rd World Small-Scale Fisheries Congress (3WSFC) that will be held in Chiang Mai, Thailand, on 22-26 October 2018.

«AWA» Ecosystem Approach to Fisheries and Marine Environment Management in West African Waters is a tripartite consortium (France-Germany-West Africa) funded by IRD and the German Ministry of Education and Research (BMBF) and 8 African partner countries.



Enhancing Prediction of Tropical Atlantic Climate and its Impacts (PREFACE) is funded by the European Union 7th Framework Programme, It is a large project (~€12M) bringing together 28 partners across 18 countries in Europe and Africa with expertise in oceanography, climate modelling and prediction, and fisheries sciences.



The Ocean University Initiative was initiated by the Breton authorities. It is implemented by the University of Brest (UBO) with the aim of creating the conditions for the establishment of an institute of the United Nations University dedicated to the ocean and the coasts, and with the means to perform prefiguration actions in three areas: research, training and communication.



Too Big To Ignore is a global research network and knowledge mobilization partnership that focuses on addressing issues and concerns affecting viability and sustainability of small-scale fisheries. TBTI comprise of more than 400 researchers and 20 organizations from around 45 countries.
