Fish shops in Brussels

We found some fish shops and market stands with perfectly fresh and good quality fish (whole, fillets, wild caught, from aquaculture); apparently well-versed and competent personnel willing to give explanations. None of the 10 shops visited around Flagey, Ixelles, St. Catherine, Midi and Place Jourdan practised EU required labelling. Blatantly undersized juvenile fish were luckily the exception or not on sale in 8 shops. Two had, however, substantial contingents of juvenile fish. With some reservations, because of poor labelling but also conscious of the limitations in our inquiries, we can recommend the following shops, where we would also buy:

- **Poissonnerie des Tongres**, Rue Bâtonnier Braffort 21-23 | 1040 Etterbeek (much handlined fish of top quality from France, combining freshness with attention to sustainable production)
- Market Stand "Chez Albert" (Sunday mornings Place Jourdan, Monday afternoons Place Van Menen St. Gilles), fresh, some labelling and openness towards sustainability concerns
- **Poissonnerie ABC** (Saint Catherine) retails fresh fish of good quality as well as meals and tapas, partial labelling and openness towards sustainability concerns
- **Poissonnerie d'Agadir** (Jourdan), good quality produce, no labels, but well-versed vendors happy to give explanations and advice about the origin of the fish in their family business

Supermarkets

We visited two shops of Carrefour without a special fish counter, but several fish fridges and the CORA at Andromeda. CORA has a sizeable fresh fish counter that is paying attention to cleanliness and service and provides good labels and contextual info. But much of the fish on offer is just cheap and undersized. The vendor was courteous, but did not come across as very well-informed.

None of the supermarkets inspired us to buy, despite better labelling than retailers.
